



2012 Juried Art Show

The Summer Arts at Dos Lagos Juried Art Show in June at The Shops at Dos Lagos will showcase original art by Southern California artists.

Artist Eligibility

1. Open to age 18+ artists residing in Southern California
2. Maximum of three (3) entries per artist.
3. Artwork must be original.
4. Oil, watercolor, acrylic, mixed media, ink or charcoal, pastels, photographs, mixed media with any of these genres; entries subject to size and weight limitations listed in rules are eligible.
5. Artwork must have been produced in past three (3) years.

Entry Rules

1. Maximum dimensions for two dimensional artwork, including frame, is 5' x 5'; maximum weight 45 pounds.
2. Artwork must be dry and properly prepared with wire for hanging.
3. Watercolors, pastels, charcoal, pencil, pen, ink, works on paper and photography must be framed and covered with glass or Plexiglass. Wrap-around paintings do not require framing.

Awards

The Jury will review all submissions for a yes or no acceptance for judging. The Jury will select winners including \$1,000 for the Best of Show selection, \$500 1st Prize, \$400 2nd Prize, \$300 3rd Prize and 14 \$200 Honorable Mention Prizes.

Jurors

The Summer Arts at Dos Lagos Jury will be comprised of art professionals such as museum curators, professors and non-competing artists.

Entry Fee = Gift Card for Artist to Spend

The Shops at Dos Lagos will give submitting show artists a Dos Lagos Gift Card valid for the total paid entry fee: One (1) entry \$20; each additional entry is \$15; maximum of three (3) entries per artist.

Entry fees may be paid by cash or credit card (American Express, Visa, MasterCard and Discover Card accepted). No checks accepted. The Dos Lagos Gift Card is valid at all merchant locations



Liability

Insurance protection for any submitted art is the sole responsibility of each artist. Artist's signature on the entry form constitutes an agreement with all listed show conditions and releases. Each artist holds The Shops at Dos Lagos, 223-1 DL Holdings, LLC, Dos Lagos Commercial Maintenance Corporation, Temescal Canyon Properties – 8, LLC, Cypress Equities Managed Services, L.P., Spinoso Real Estate Group, as well as each such entities' members, partners, shareholders, officers, directors, agents, licensees, invitees, employees, lessees, customers, sponsors,

representatives, show staff, volunteers, and anyone else connected with the Art Show (collectively, "Indemnified Parties") its owners, agencies and merchants, show staff, volunteers, and anyone else connected with the show, harmless from any and all claims which may occur by reason of loss or damage from coming onto the Shops at Dos Lagos and to the submitted works of art while in possession or control of the show, and each artist agrees that all accepted artwork may be photographed for show promotional purposes.

Artist Notification

Artists will be notified of acceptance or non-acceptance via email on May 18, 2012. Accepted artists names will be posted at www.ShopDosLagos.com by May 19, 2012. Accepted artists will be invited to attend a private Summer Arts at Dos Lagos reception, where the winning artists will be announced. Winning artists will receive their checks after they provide a completed 1099-form.

Art Sales & Commission

Only Jury selected artwork will be offered for sale during the show. The Corona Art Association and the Riverside Arts Council will manage gallery artwork sales to collect payment and sales tax by cash or credit card (Visa and MasterCard). Only cash or credit card accepted. The Corona Art Association and the Riverside Arts Council will each receive a 15% commission, total of 30% commission, for each sold artwork. For example, if a painting sells for \$300, the artist will be paid \$210.

Artists may pick up checks for any sold artwork on Saturday, June 30, 2012 at the Summer Arts at Dos Lagos Gallery from 3 to 7 pm after the artist provides a completed 1099-form.

Art Show Close

All unsold artwork must be picked up on Saturday, June 30, 2012 between 3 – 7 pm at the *Summer Arts at Dos Lagos* Gallery. Any artwork not picked up will be moved to the Corona Art Association, located at 522 Corona Mall, Corona, CA 92879. To arrange pick-up after June 30, 2012, call the Corona Art Association at 951.735.3226. Any artwork not picked up at the Corona Art Association by September 1, 2012, will become the property of the Corona Art Association and may be discarded or sold with any proceeds donated to the association.
